Sub-: Observance of Vigilance Awareness week from 30th October to 04th November 2017.

It has been decided by the CVC/HQrs office to observe **Vigilance Awareness Week from 30<sup>th</sup> October to 04<sup>th</sup> November 2017.**

2. Accordingly, the undersigned has been directed to convey that the Vigilance Awareness Week may be observed in your offices too. The week will commence with the pledge (copy enclosed) on **30<sup>th</sup> October 2017 at 11 AM**. This year the theme of observing Vigilance Awareness Week is **“My vision – Corruption Free India” (मेरा लक्ष्य – भ्रष्टाचार मुक्त भारत)**.

3. It has been advised by the commission to place effective preventive measures to fight against corruption and also to enhance transparency and accountability in the functioning of department. Further opined by the commission that e-governance combined with systemic changes in procedures, minimal discretion, reduced public interface technology based procurements and automation will go a long way in tackling corruption. Therefore, the commission has chosen **“My Vision – Corruption Free India”** as the central theme for Vigilance Awareness Week-2017. **The earlier pledge has been replaced by the Integrity Pledge.**

4. It is advised to consider the following activities during the Vigilance Awareness Week as indicated by the CVC.

- (a) All employees may be encouraged to take e-Integrity Pledge by visiting the CVC website [www.cvc.nic.in](http://www.cvc.nic.in) or the “Integrity Pledge” link provided on CDA Jabalpur website [www.cdajabalpur.nic.in](http://www.cdajabalpur.nic.in) under ‘Links to CGDA & other website’ in addition to pledge at 11 AM on 30.10.2017.
- (b) To display anti-corruption banners, posters etc. at prime locations of office premises.
- (c) To conduct workshop/sensitization programmes for employees and other stake holders on policies/procedures of the organization and preventive vigilance measures.
- (d) To conduct various competitions such as debates, quiz etc. for the employees and their families on issues relating to anti-corruption.
- (e) Use organization website for dissemination of employees/customer and oriented information and avenues available for grievance redressal.
- (f) To promote the concept of e-integrity pledge by persons with whom your office is dealing.
